On this date, we, the Board of Trustees of the <b>Cross Plains Independent School District</b> , hereby levy or set the tax rate on \$100 valuation for the District for the tax year <b>2021-2022</b> at a total tax rate of <b>\$ 0.9857</b> , to be assessed and collected by the duly specified assessor and collector as follows:
\$ 0.9857 for the purpose of maintenance and operations, and
\$ 0.00 for the purpose of payment of principal and interest on debts.
Such taxes are to be assessed and collected by the tax officials designated by the District.
Adopted this 31st (date) day of August (month), 2021 (year), by the Board of Trustees.
